Walker, appeals the district court's denial of his habeas petition filed pursuant to 28 U.S.C. Sec. 2254. For the reasons that follow, we affirm. 2 In 1973, Walker was tried in the Criminal Court of Bradley County, Tennessee, for the murder of James Streetman. Walker was convicted of voluntary manslaughter and his sentences were to be served consecutive to his sentence for armed robbery. On direct appeal to the Tennessee Court of Criminal Appeals, Walker argued that the conviction was based upon an involuntary confession. On April 14, 1974, the court affirmed the conviction. Walker thereafter sought a writ of certiorari from the Tennessee Supreme Court. In that application, Walker argued that the evidence was insufficient to convict him. That application was denied. Walker then petitioned the United States Supreme Court for a writ of certiorari on that issue and the denial of that writ is now the subject of this federal habeas action. 3 Walker also claims that he was denied effective assistance of counsel. At the criminal trial, Walker's attorney made no motion to suppress his
